# FAIRPORT POP WARNER 2010 REGISTRATION INFORMATION

## REGISTRATIONS:

- Veterans registrations accepted after 1/1/10 and due by 1/31/10.
- After 1/31/10, registrations will be accepted in person at general registration, 2/6/10 @ Perinton Square on a first-come, first-serve basis or through the mail after 2/6/10 for Fairport Residents.
- New player registrations for residents of surrounding areas will be accepted after 2/13/10

## REGISTRATION FEE

- \$125 per player/cheerleader, \$275 max per family.
- \$10 deduction per additional player/cheerleader

## OUTSTANDING EQUIPMENT

- Must be returned before registration will be accepted.

## "MANDATORY WEIGHT LEVELS" - FOOTBALL

- Please register your child based on his appropriate age/weight (see chart on reverse).
- Fairport Pop Warner reserves the right to change player levels based on inaccurate information given at registration. Movement will be made only after parent contact.
- Please weigh your child when completing registration forms. All players at general registration will be weighed.
- It is the responsibility of parents/players to monitor their weight until equipment hand-out in June or July when they will be weighed again. If the player is 6 pounds or over the maximum weight level, he/she will be asked to move up to the next level (as long as age is applicable). National Pop Warner rules do not allow players that are 6 pounds over the maximum weight to participate in practice.
- Should the parent/player refuse to do so, they will be asked to complete a "Weight Restriction" form outlining their responsibility and the certification process.
- Certification takes place at the end of August. At that time, players within the age/weight mandated levels and approved paper work, will be considered "certified" to participate in the first game. Parents/coaches of those players not "certified" will be advised of future certification opportunities.
